# Reference Price Offer: Active/ Lit Wholesale Transport Services

- Physical redundancy cannot be offered on the arterial routes from RMH to the secondary Points of Presence,
   based on network design and architecture. Redundancy can only be offered initially between RMH and Calgary.
- Gateway/Internet access can be supplied if requested, at a charge of cost-plus administration charges.
- Multi-Point Layer Switching (MPLS) can be added on if required.
