3. Ahlstrom Air Ltd.

M. Ahlstrom noted the current 'Provincial Parks Act' restricts aircraft operation in a park or recreation area except where allowed to do so by Ministerial order and/or permit. If unable to operate within the proposed parks, Ahlstrom Air anticipates significant revenue losses.

As per legal counsel, contradictions between the bankruptcy and insolvency legislation and the Municipal Government Act present challenges for municipalities in the collection of pre and post-receivership tax debt from corporations in receivership.

To overcome these challenges, legal counsel advises that Council pass a resolution, as authorized by Section 347 of the Municipal Government Act, to defer 'pre-receivership tax until the earlier of payment of all post-receivership tax or disposition of the property that is subject to the tax assessment.'

That Council directs Administration, as authorized by Section 347(1)(c) of the Municipal Government Act, upon written request from a Receiver, to defer all prereceivership tax arrears and accrued penalties owing for pre-receivership tax arrears in situations where corporations have gone into receivership, until the earlier payment of all post-receivership taxes or the disposition of the property that is subject to the tax assessment.
