1. Speight Road/Cow Creek Committee

- S. Williams and J. Winchester explained Speight Road/Cow Creek Committee's reasons for asking Council to consider paving Speight Road (Township Road 39-0) up to Cow Creek Road (Range Road 8-0), as follows:
 - 1. Residents petitioned for paving Speight Road in 2010.
 - 2. Traffic counts collected in 2012 and 2014 indicate a high volume of industry traffic.
 - 3. Residents are dissatisfied with existing dust control applications and are concerned about how dust, created by the high traffic volume, affects road safety and their quality of life and health.

Discussion followed, and S. Williams and J. Winchester responded to questions.

Administration responded to questions and confirmed Speight Road is classified as a 'resource road' and that an updated traffic count will be considered during 2019 budget deliberations.

2. Big Brothers Big Sisters Red Deer & District - Camp Alexo

Big Brothers Big Sisters Red Deer & District (BBBS) is a charitable organization that provides opportunity for children and youth to attend summer programs at Camp Alexo located east of Nordegg.

BBBS representatives, J. Boyd, Executive Director and N. Frank, Camp Alexo Facility Coordinator, presented a PowerPoint, "Camp Alexo Phase 3 (Lodge) Case for Support Presentation — September 11, 2018". The presentation outlined the three-phase capital project for new and renovated facilities and infrastructure at Camp Alexo. The project is now in the final phase and once completed will expand the camp to accommodate more campers and operate year-round.

The final phase of the project is 98.5% funded by cash and in-kind donations and volunteer hours and BBBS asks that Council consider granting \$15,412.00 to complete the project.

Discussion took place and the following points were made:

- The requested funding amount equates to the percentage (approximately 1.6%) of local youth/children that participate in Camp Alexo's programs.
- Camp Alexo, with its capacity to run 'off-grid', may be used as an evacuation centre.
- BBBS works with media to promote Camp Alexo which impacts tourism in the surrounding area.
