#### 5.2 Telecommunication Tower Policy

- K. Gilham explained Innovation, Science and Economic Development Canada's (ISED) process for approving installation of antenna systems, including masts, towers and other antenna-supporting systems, for radiocommunication and broadcasting services that includes the requirement for local land-use authority and public consultation.
- K. Gilham reviewed ISED guides and protocol templates that are available for municipalities to use in developing local protocols to manage consultation requirements and address concerns related to proposed system installation.

Discussion took place and it was noted that although ISED is the governing body over tower installation, it would be advantageous for the County to develop policy for improved consultation and notification processes. However, the policy should not complicate the process and include exemptions for consultations as identified by ISED.

The Public Hearing process was outlined by Reeve Hoven, Chair.

J. Reyes stated that as per legislation in the Municipal Government Act, two or more councils of municipalities that have common boundaries must adopt an intermunicipal development plan (IDP) to include those areas of land lying within the boundaries of the municipalities as they consider necessary.

The content of the IDP being presented is the result of several discussions between the two Counties and input collected through a public engagement process.

- J. Reyes explained the purpose and concepts of the statutory policy for the Intermunicipal Development Plan (IDP) between Wetaskiwin County No. 10 and Clearwater County. He explained the goal is to coordinate land use planning and infrastructure decisions to ensure the interests of both counties are taken into account. Topics covered in the IDP include:
  - Context and background about major features that shape the available options for future land uses in the area (e.g. limits from pipeline setbacks);
  - Land use patterns showing the locations for major existing residential, commercial and industrial areas of activity;
  - Major existing road and pedestrian corridors and networks;
  - Preservation of significant natural features;
  - Coordination of economic development efforts;
  - · Potential sharing of facilities and services;

- Processes for ongoing communication and resolution of issues that may arise; and
- Existing municipal boundaries;
- Processes to administer the plan including an Intermunicipal Committee and process for referring planning applications for comments.

At the Clearwater County's October 22, 2019, regular council meeting Council reviewed and gave first reading to Bylaw 1074/19 which intends to adopt the Clearwater County - County of Wetaskiwin No. 10 IDP. Subsequently, the County of Wetaskiwin No. 10 gave first reading to its Bylaw 2019/49 for the same purpose on November 8, 2019. A public hearing, as well as second and third readings of the bylaw, are anticipated to take place on December 5<sup>th</sup>, 2019 at the County of Wetaskiwin.

He also noted as required by legislation and public participation policy, the proposed bylaw was available for public review on both of the Counties websites and circulated to residents within the area; notice of today's Public Hearing was advertised in the local newspapers and comments were invited from landowners adjacent to the IDP boundaries and referral agencies.

The Chair invited questions from Council regarding the proposed bylaw.

No questions were asked.

The Chair invited comments from referral agencies.

#### Property Owners

Written comments received from property owners along the common border asks that the Plan address protection of watersheds, wildlife corridors, forest and conservation areas, rural neighbourhoods and specific archeological sites.

J. Reyes stated that based on these comments, revisions were made to the draft IDP to reference specific areas within the Plan. In the final version, references to the Plan Area being primarily located within the North Saskatchewan Watershed Modeste Sub-basin as well as the Red Deer Watershed Medicine Sub-basin were made. References to the Rose Creek, Horseshoe Creek and Washout Creek and the Horseshoe Creek Natural Area in the Plan Area were also made.

Other public comments including references to geographic, sociological, economic or historical details are being deferred to future and more specific planning documents such as Area Structure Plans and/or Outline plans.

#### Alberta Transportation

Alberta Transportation expressed no objections to the IDP but pointed out that if the adjacent lands around Highway 22 develop, coordination between the County of Wetaskiwin and Clearwater County may be needed to cost share the Township Road 450 and Highway 22 intersection upgrade.

#### Alberta Health Services

Alberta Health Services provided high level comments regarding neighbourhood design, housing, natural environments, transportation network and food systems. These comments are being deferred to future and more specific planning documents such as Area Structure Plans and/or Outline plans.

#### Clearwater County Public Works

Clearwater County Public Works Department expressed no objections and/or concerns.

The Chair invited the Applicant to speak to the proposal, add any comments in support of the request and, respond to the agency comments.

No additional comments were made.

The Chair invited comments from the public in favour of the proposed bylaw.

Rose Marie Sackela requested that the IDP reference 'No Exit' roads in the plan area.
