1. Clearwater County North Development

Mr. Morton presented tender results for the grading and other work scheduled for the County's North Development. The tender includes the construction of a storm water management pond, gravel access road, lot grading and the construction of the salt/sand storage base facility.

The tender opening was held June 9, 2016 with 7 bids received. The successful bid came in at \$732,940.00 under the budgeted amount which is \$1,646,500. The project is expected to be completed by fall of 2016.

1. AAMDC Broadband Survey

Mr. Hickey presented an Alberta Association of Municipal District and Counties (AAMDC) survey to Council in regards to Municipalities and broadband development and the Alberta SuperNet. The survey was created to identify priorities related to broadband development and the Alberta SuperNet to strengthen AAMDC's understanding to advocate for these initiatives.

Council discussed the survey noting that while Clearwater County residents have access to internet services service is limited in many areas or only available via satellite. Topography, resident/business density and technology were all identified as constraints to broadband service provision.

Council's collective response to the AAMDC's member survey and that Councillor's may submit individual

responses as well.

2. Taimi Hall

Mr. Pratt provided an update on the status of the Taimi Hall, which is located on 2 acres of land Northeast of Rocky Mountain House.

Mr. Pratt noted that since earlier 2016, Administration has been working with executive members of the Taimi Hall Association and the adjacent land owner (Leaser) in an attempt to resolve issues relating to securing title to land as well as meeting reclamation requirements relating to the leased land on which the hall is situated.

Mr. Pratt advised that this project was not anticipated in the 2016 budget and recommended that Council authorize the transfer of \$40,000 from Contingency to the Community and Protective Services budget for costs associated with demolition and removal of the Taimi Hall, removal of utilities, surface reclamation and legal costs associated with land transfer.

COUNCILLOR GREENWOOD: That Council authorizes the transfer of

\$40,000 from Contingency to Community and Protective Service budget and authorizes Administration to complete the demolition of Taimi Hall, reclamation of leased lands and the transfer of land title.

Mr. Leaf presented an overview of public engagement concepts engagement model.

A number of public engagement strategies were discussed including; resident questionnaire; group or organization meetings; open café meetings inviting community groups, businesses and residents together to discuss and answer priority questions. Administration noted that Bill 21 (Modernized Municipal Government Act) will require municipal Councils to formally adopt a public participation process. The requirements of the Act are anticipated in the fall, following proclamation of Bill 21.

3. Delegation – CCI Wireless

Mr. Graham Fleet, Marketing Manager for CCI Wireless, presented a power point with an overview of CCI Wireless, their history, present status and plans for the future.

CCI has 160 live towers throughout Alberta, covering over 200,000 square miles. Seven of the towers are located in Clearwater County, serving over 1300 customers. Five have been upgraded to LTE.

CCI Wireless offers three packages, each offering unlimited data as well as Enterprise Solutions Circuit.

Mr. Fleet answered questions regarding upload and download speeds and noted that CCI Wireless is working on an initiative to provide fibre to the base of towers. Mr. Fleet added that it is important to balance wants vs. needs in the technology industry. CCI anticipates that with the rapid advances in technology that the devices being used to connect to the internet will increase three-fold in the next few years.
